

Important Privacy Notice for the Ezy-Way Credit Facility™

This Privacy Notice is provided by: Menswear Finance Co Pty Ltd ABN 21 002 677 778 ("EZY-WAY")

This Privacy Notice contains important information about the collection, use and disclosure of your personal information by Ezy-way. Where personal information is collected, used and disclosed for the same purposes by Ezy-way, the word "we" or "us" is used. Ezy-Way has a contractual arrangement with Retailers to provide the Ezy-Way Credit Facility to approved customers to facilitate credit purchases of goods and services at a Retail store.

By completing the Application Form, you acknowledge and consent to all of the matters set out in this Privacy Notice, including the collection, use and disclosure of your personal information by EZY-WAY.

1. COLLECTION OF PERSONAL INFORMATION

1.1 Types of information collected and how.

Generally the information that we collect is provided in and during the course of your application as well as transaction information when you shop at a retailer store such as, but not limited to the store(s) you purchased at, date(s) of purchases and the method of payment. Other types of information collected are as follows;

- Information relating to your Credit Facility Account, your ongoing use of that account and your credit limit;
- Personal information including, your Credit File, Bank Account Transaction and Identity information to assist in the assessment of your credit worthiness
- Information you may provide from when contacting Ezy-Way, Menswear Finance Co Pty Ltd or associated companies and other retailers;
- Information you provide when using your card on our Ezy-Way websites;
- Information held by a service provider (for example, a loyalty program operator, a customer service organisation and others described below under "*Who your personal information may be shared with*").

2. USE AND DISCLOSURE OF PERSONAL INFORMATION

1.2 Why personal information is used and disclosed

We collect personal information for a number of purposes for reasons stated below:

- To perform administrative tasks and manage business operations related to the card and any associated loyalty program, including dispute resolution;
- To provide any associated loyalty program;
- To promote and provide benefits associated with the card and discounts to which you are entitled;
- To promote and provide products, services and offers (including special promotions, events, product launches and other special offers and discounts through various communication channels) of Ezy-Way and members of the Ezy-Way and other related entities and other organisations (although, for this purpose, your personal

information will only be disclosed to related companies and to service providers as described in this Important Privacy Notice);

- For planning, product and service development, marketing and research purposes;
- For risk assessment modelling;
- For fraud and crime prevention and investigation;
- To comply with legislative and regulatory requirements;
- To process your application for an Ezy-Way Credit Facility.

Menswear Finance Co Pty. Ltd. may also use and disclose your personal information to assess your application for an Ezy-Way Credit Facility and if approved, for the establishment and subsequent administration of the credit facility (see below);

- To provide your personal information to Ezy-Way for the purposes set out in this Privacy Notice; and

If this personal information about you is not provided to us, it may result in Ezy-Way being unable to provide benefits associated with Ezy-Way Credit Facility. Menswear Finance Co Pty. Ltd. will also be unable to process your application, or to establish or administer the credit facility.

Collection, use and disclosure by Menswear Finance Co Pty. Ltd. of your credit application information and other credit information about you

To assess your application for credit, Menswear Finance Co Pty. Ltd. may also collect the following information about you in a manner and for purposes that conform to the Privacy Act:

- A credit report containing personal information about you from a credit reporting agency;
- Your bank account transaction for assessment of your credit worthiness
- Information about your commercial activities and commercial credit worthiness from a business or an individual which provides commercial credit worthiness information; and
- Menswear Finance Co Pty. Ltd. may use that report (and information derived from it) and that information to assess your application for credit and for other purposes permitted by the Privacy Act.

Menswear Finance Co Pty. Ltd. may share information about your credit arrangements with any credit providers named by you in this Application Form and any credit providers named in a credit report obtained by Menswear Finance Co Pty. Ltd. issued by a credit reporting agency in a manner and for purposes that comply with the Privacy Act, including to assess your application for credit and your credit worthiness.

Subject to the Privacy Act, Menswear Finance Co Pty. Ltd. may also share information concerning a credit facility granted to you or the conduct of that credit account.

3. WHO YOUR PERSONAL INFORMATION MAY BE SHARED WITH

3.1 To perform activities for any of the purposes set out in this Privacy Notice, we may share your personal information with:

- service providers such as customer service organisations, call centres, data analysts, professional advisers, auditors, organisations providing services and rewards relevant to any associated loyalty program, delivery companies, card manufacturers, mailing organisations; and
- Other organisations as required or authorised by law, for example, to government or regulatory bodies for the prevention or detection of unlawful activities.

3.2 Ezy-Way may also share your personal information with:

- Additional Ezy-Way cardholders or other persons (if any) authorised by you to operate or access your Ezy-Way Credit Facility account;
- Ezy-Way stores, but only for the purpose of facilitating the processing of transactions through electronic switching systems, and for processing payments;
- Program partners for any loyalty program associated with your card, and
- Business partners from time to time for analysis and research purposes and in the development of products and services and promotional offers.

Menswear Finance Co Pty. Ltd. may also share your personal information with:

- Ezy-Way (and this may include, without limitation, sharing of your Ezy-Way Credit Facility credit limit, Ezy-Way Credit Facility numbers and additional cardholder(s) (if any) and other information in order to process your application for a Ezy-Way Credit Facility);
- Credit reporting agencies;
- Other financial institutions and credit providers;
- Your nominated referees, including your employer;
- Additional cardholders or other persons (if any) authorised by you to operate or access your credit facility;
- Organisations through whom you choose to make payments to;
- Ezy-Way stores, but only for the purpose of facilitating the processing of transactions through electronic switching systems, and for processing payments; and
- Providers of services related to the card such as statement producers, debt collection agencies and card manufacturers.

Safeguarding personal information

Ezy-Way and Menswear Finance Co Pty. Ltd. will take reasonable steps to protect personal information about you that they hold and transmit, from misuse and loss and from unauthorised access, modification and disclosure.

Transfer of your personal information overseas

In some circumstances, for the purposes set out in this Privacy Notice, your personal information may be transferred by the Ezy-Way to organisations located overseas. Where such transfers occur, arrangements will be put in place to protect your personal information.
